



# Camping de l'Arche



## Internal Rules

Staying at the campsite implies acceptance of the provisions of these regulations and the commitment to comply with them.

In the interest of all our guests, please observe the following points:

1. Anyone wishing to enter or stay at the campsite must first check in at the reception.
2. Wearing a wristband is mandatory for all guests from the opening of the campsite.
3. Nudism, even partial, is prohibited, including on the beach and rocks.
4. Our guests should avoid all noises that could disturb their neighbors (non-exhaustive list):
  - Sound devices must be adjusted accordingly.
  - The closing of car doors and trunks should be as discreet as possible.
5. Silence is required between 10:00 p.m. and 7:00 a.m.

**6. Vehicles:**

- Only vehicles belonging to campers staying on-site can circulate in the campsite.
  - Car parking is allowed for each camper only on the allocated pitch.
  - The speed limit is 10 km/h.
  - Entry and exit barriers are open from 7:00 a.m. to 10:00 p.m.
  - The main gate is open from 6:30 a.m. to 11:00 p.m.
7. Everyone must refrain from actions that could harm the cleanliness, hygiene, and appearance of the campsite and its facilities. Everyone must ensure their installation looks tidy and their pitch/accommodation is clean. It is strictly forbidden:
- To smoke/vape in accommodations and inside buildings.
  - To drive nails into trees.
  - To cut branches.
  - To use plastic ground sheets. Guests must ensure that their accommodation/pitch is left clean and cleared at the end of their stay (remove clotheslines, stones, litter, etc.). Wastewater must be emptied in the facilities intended for this purpose.
8. The sanitary facilities are not a playground. We ask parents to explain to their children not to play in the facilities and to respect other campers by keeping music at a moderate volume.
9. Plantations, the natural environment, and facilities must be respected.
10. Guests commit to protecting the environment by:
- Sorting waste correctly according to color codes.
  - Not throwing paper, cigarette butts, cans, bottles, etc., on the ground, but in the designated bins.
  - Water is an essential resource; please do not waste it.
  - Washing vehicles on pitches is prohibited.

11. The aquatic area is strictly reserved for campsite guests. Children under 10 must be accompanied by an adult. Please respect the safety instructions displayed at the entrance of the aquatic area. Only the following swimsuits are allowed:



12. Guests receiving visitors during the day must inform reception. Visitors must pay the visitor rate as indicated in the price list and park their car outside the premises. Access to the aquatic area is strictly prohibited for visitors.

13. **The River:** The Gardon d'Anduze and its banks are a natural area. Swimming is not supervised, and everyone accesses it at their own risk. The risks related to this natural area include (non-exhaustive list): falls leading to burns, fractures, sprains, dislocation, death, drowning.

#### 14. **Safety Instructions:**

- Our establishment is ideally located on the riverbank. It is partly classified as a flood-prone area by prefectural decree. In case of flooding, follow the instructions. The evacuation plan is available at the reception, restaurant, and in each sanitary block. The evacuation concerns people only.
  - By prefectural decree, using charcoal barbecues in campsites is prohibited. Only gas or electric barbecues are allowed.
  - Campfires are strictly prohibited.
  - No non-compliant electrical connections are tolerated.
  - By prefectural decree, it is forbidden to connect electric vehicles to non-designated outlets. The use of dedicated charging stations is mandatory (located at the campsite entrance).
15. Dogs are allowed on a leash, with a valid vaccination card/passport and identification by tattoo. They cannot be left alone, even when tied up, in the absence of their owners, who are civilly responsible for them. Out of consideration for other campers and the establishment:
- It is forbidden to let dogs urinate in the campsite.
  - Waste bags are available: use them, even around the campsite.
  - Dogs are allowed to swim only under the beach volleyball area. First and second-category dogs are prohibited in the campsite.

16. In recent years, we have observed a decline in the behavior of some campers, particularly young teenagers. Mutual respect and good manners seem not to be understood by some. As a result:

- For parent(s) or guardian(s):
  - I formally commit to supervising my children and teenagers.
  - I ensure that I and the persons under my responsibility observe all the provisions of these regulations throughout our stay.
- For children or teenagers:
  - I respect others' rest by not making noise in the campsite after 10:00 p.m., i.e., around the restaurant, in the sanitary facilities, and when going to or returning from the rocks.
  - I will not cause inconvenience or damage to neighboring properties or other areas of the village.
  - I will not leave litter, cans, bottles, papers, cigarette butts around playgrounds, beaches, and rocks. Failure to comply with these provisions, particularly the nighttime silence, will result in a sanction requiring the violator to remain in their accommodation/pitch overnight (from 10:00 p.m.) for the remainder of the stay.

17. The site is under video surveillance.

18. **Conclusion:** Once again, we kindly ask you to take these guidelines into account.

Non-compliance with these regulations will result in expulsion without compensation on the second warning. Respecting this charter guarantees a truly enjoyable vacation for everyone!
